Penalties, Fees and Court Costs may be imposed by Governing Agencies for violation of dog licensing laws. Current rabies information must be submitted before a dog license can be issued. A \$10.00 late fee shall be collected (where applicable) from owners of dogs not licensed as of April 1st of each year, as provided by the provisions of Chapter 174 of the Wisconsin Statutes.

Every person who owns, harbors or keeps a dog that is more than five months old in the Town of Jackson, must license the dog(s). Fill out the "Application for Dog License" completely. Current rabies information must be provided in order to obtain a dog license. This includes the rabies vaccine manufacturer, the vaccine serial number, the rabies expiration date and the veterinarian/veterinary clinic. All dogs more than five months old must be vaccinated against rabies.

A \$10.00 late fee shall be collected for every dog not licensed as of April 1st of each year or within 30 days of owning a licensable dog.

If a dog license is no longer needed for a dog that was licensed in 2016 please fill out the Affidavit and return it to the Treasurer so that the dog's name may be removed from the list.

Enclose a stamped, self-addressed envelope for return of the dog license and dog tag. If you included the application and payment in the envelope with your tax payment, only one return envelope is necessary.
