WHEREAS, the Town and the Village have reached an agreement, as more particularly described in the "Mediated Cooperative Plan Agreement Between the Village of Jackson, Wisconsin and the Town of Jackson, Wisconsin" ("Agreement"), a copy of which is attached and incorporated by reference; and




NOW THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Jackson does hereby approve the Agreement; and


