- 2. To adopt the 2018 Town Tax Levy** to be paid in 2019 pursuant to 60.10(1) (a) of the Wisconsin Statutes in the amount of **\$914,704.**

The members of the Town Board may engage in discussion and information sharing in their capacity as Town Board Members at the called Town Meeting, but no action of the Town Board will be taken.
